Fiscal Sponsorship: Fresh Arts offers a Model C fiscal sponsorship program. As the fiscal sponsor, Fresh Arts provides fiduciary oversight, financial management, & other administrative services to help build the capacity of charitable projects. Fiscal sponsorship creates a new class of professional artists in Houston who, through the program, have a platform to receive support for their work, the freedom to be innovative without excessive administrative burden, & the privilege to focus on their given area(s) of expertise. In 2021, Fresh Arts distributed \$88,956 to 30 projects across the multiple disciplines.

Community Programs: Through Fresh Arts' management of Arts District Houston, a state-designated cultural district that is home to 400+ local artists, Fresh Arts supports the local arts ecosystem by creating opportunities for artists to showcase their work & for the public to participate in arts activities outside of traditional institutions. Our programming provides more access for residents to experience art where they live & more equality of opportunity for the city's diverse artist community. Our public art projects showcase Houston's creative talent & provide free, high-quality arts experiences for 330,000 residents & visitors each year.

Skill Building Programs: Fresh Arts provides on-demand web resources to enhance the marketing & promotion of artists' work & events as well as to strengthen artists' capacity to succeed in the business of art. Online and Face-To-Face Professional Development Workshops: Fresh Arts' in-person career building workshops offer Houston's artists a "nuts and bolts" approach to their creative business. This includes Artist Inc, a series of innovative training seminars that addresses the specific business needs artists of all disciplines face.
